- 5) **Emergency Community Plan** – A reply is still awaited from NYCC

- 6) **Cold Calling Survey**
30 people completed survey.
C Cookman proposed that the completed survey be forwarded to PCSO Chris Wood. All members present agreed
- 7) **Development South Back Lane and York Road Drain**
P Swiers confirmed that work had been carried out on soakaways.
Pond now filled in.
- 8) **Community Speed Watch**
Speed continues to be monitored within the Village.
R Conway proposed that an update be put in the Stillington News.
All members present agreed
- 9) **Landscaping – Village Hall**
Stillington Sports and Social Club has released funds and letter forwarded to Hambleton District Council.
P Swiers stated a delay of approximately two weeks before work can commence.
- 10) **White Fencing and Posts**
Twenty two posts are to be replaced at a cost to the Parish Council of £526.44 plus VAT. The fitting of post guards to be investigated
- 11) **Telephone Box Main Street**
B Smith to fit lower shelf. Agreed to take off the agenda.
- 12) **Neighbourhood Watch**
Hare coursing is still a problem.
Public to be made aware of lead being removed from buildings.

- 13) **Crabtree Cottage. The Green Stillington**
It was agreed to check on progress of the removal of fencing and to confirm if the area in front of the property is to be reinstated.
- 14) **Road around the Green**
A letter from Tim Richards to be discussed at next Parish Council Meeting.
- 15) **Replacement Tree on Top Green**
C Cookman to confirm the amount of the donation with the Donor
P Swiers to check on the specification of the tree
Parish Council are covering the planting costs
- 16) **South Hambleton Shale Gas Advisory Group (SHSGAG)**
P Swiers reported on information sent to all Parish Council Members
Change of date for meeting. Now Tuesday 13 March 2018
- 17) **Lucy Balk**
A member of the public has complained about the condition of Lucy Balk. After discussion it was agreed that no action would be taken at this time
- 18) **Dog Fouling**
Dog Fouling continues to be a problem. A notice to be placed in the Stillington News requesting people to use the dog waste bins or take the waste home. Also, a request for dog owners to keep their dogs on leads while walking across farmland so as not to disturb ground nesting birds and wildlife or damage crops.
- 19) **Ditches at bottom of Mill Lane**
Councillor P Swiers reported back that no action needed to be taken at present.

- 19a) P Swiers also reported a pothole in Mill Lane and a blocked Drain on Brandsby Road. Hambleton Council and NYCC to be informed.
- 19b) **Road Subsidence at Mill Lane**
Further action is required on the Road Subsidence at Mill Lane and will be reported to the Highways Department.

P Swiers apologised for the salt bin not being filled as there was no salt available. Agreed to leave until October 2018
 - c) Drain blockage North Back Lane
Councillor C Cookman reported that this was due to wet wipes and a note would be placed in the Stillington News
