22/15 APOLOGIES

22/17 CO-OPTION

Cllr Tracy Sinclair was co-opted onto the Council and welcomed by the Chairman. Cllr Sinclair signed the declaration of acceptance of office.

22/18 WILDFLOWER SEEDING

A report on potential wildflower seeding in the village was given by Helen Stainsby. It was agreed to investigate wildflower seeding on the top green and discuss this with the grass cutting contractor.

- b. District Councillor Watkins reported on the latest Local Government review position.

- b. The planning application for the work on the willow tree at the pond was ongoing.
